Report on the Audit of the Financial Statements

Opinion

We have audited the standalone financial statements of BOI Shareholding Limited. ('the Company'), which comprise the Balance Sheet as at 31st March 2022, the Income & Expenditure Account and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India including the Accounting Standards notified u/s 133 of the Act, of the state of affairs of the Company as at March 31, 2022, its loss and cash flows for the year ended on that date.

Basis for Opinion

We conducted our audit of the financial statements in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013.
